- Current Public Liability Insurance Certificate of \$10M (The Sydney Harbour Foreshore Authority as Interested party)
- Proof of identification
- Parental consent form (if under 18 years of age)
- A recent passport photo

Buskers wishing to perform using dangerous materials at the sites covered by this policy are required to hold a current City of Sydney Busking Permit (please refer to cityofsydney.nsw.gov.au).

I / we the undersigned, declare as follows:

- I will display my Sydney Harbour Foreshore Authority Permit to busk in a prominent position in close proximity to where I am performing at all times.
- I will make my Permit available for inspection by an authorised officer of the Sydney Harbour Foreshore Authority upon request and follow any lawful direction issued by that officer.
- I will not transfer this Permit to any other person.
- I agree that this Permit does not give me sole use or reservation of a busking pitch.
- I will use designated sites in restricted areas in accordance with the conditions of The Rocks and Circular Quay Busking Policy.
- I will not create a threat to public safety, whether real or perceived.
- I have read and understand The Rocks and Circular Quay Busking Policy and agree to operate in accordance with the terms and conditions attached to this Permit.
- I agree to indemnify the Sydney Harbour Foreshore Authority against any expense, loss or liability incurred as a result of my act or omission that results in personal injury or to the death of any person, or the loss of or damage to any property, occurring in connection with my performance.
- I acknowledge and agree that I use and occupy the Sydney Harbour Foreshore Authority's designated busking pitches solely at my own risk.

- I release the Sydney Harbour Foreshore Authority from and against any loss (including loss of income), claim, demand, action, suit, proceeding, cost, expense, penalty, payment, damage, liability or deficiency of any kind arising from or in relation to the granting by the Authority of a Busking Permit to me.
